"Promote Human Rights, Act against Rape!" 10 December 2013, 14.30-16.30h, European Parliament, Strasbourg Venue: Room Louise Weiss S2.1



On the occasion of the International Human Rights Day (10 December), and in the framework of the Joint project with the Council of Europe "Act against Rape! Use the Istanbul Convention!", the European Women's Lobby (EWL) is organising a round-table, co-hosted by MEPs Mikael Gustafsson and Antonyia Parvanova.

The purpose of this event is to present Europe-wide challenges in responding to sexual violence in any area – legislation, policies, services, practices of professionals – and highlight the positive changes that the Istanbul Convention can bring in this field. This will be an opportunity to reassert that women's rights are human rights and bring to the attention of members of the European Parliament that rape is a persistent violation of women's rights, while demanding justice and support for victims of rape.
